**2021 MEMBERSHIP APPLICATION**

**INSTRUCTIONS:**

- Use this application to apply for new membership to PPC or to renew existing membership.
- All members (Primary, Spouse, & each Junior) must submit an individual application.
- A membership application is required to be completed in its entirety for the Primary, Spouse and each Junior member.
- Renewing members can either drop off the application at the Club on the 3rd Thursday evening of the month or mail completed application and dues to the address above. **INCLUDE A SELF-ADDRESSED, STAMPED ENVELOPE ONLY IF YOU WANT YOUR NEW MEMBERSHIP CARD MAILED BACK TO YOU OR YOU MAY PICK IT UP AT THE CLUB.**
- New applicants for membership must appear at the club on the 3rd Thursday evening of the month with their firearm, ammunition, and be prepared to fire 50 rounds for a safety evaluation. Please also bring whichever applies: NJ Firearms ID Card, Concealed Carry Permit from any state, Law Enforcement credentials or other verification that you are legally eligible to own/possess a firearm, NRA or other training certifications and NRA membership card.
- **A member is PROVISIONAL until completing a PPC New Member Training (safety training).** Provisional members are permitted to shoot only when a range safety officer is present (Hosted Shoot).
- **Provisional members must complete the PPC New Member Training** within the time period of four consecutive PPC New Member Trainings (typically offered quarterly). Failure to do so will disqualify provisional members from renewing membership until safety training has been completed. Proof of completion of safety course determined equivalent by the PPC Board of Directors will satisfy the above.

As a result, I could be seriously injured or killed by my actions or the actions of others. Despite this full knowledge, I want to either join or renew my membership. I further acknowledge and understand that prolonged participation in any shooting activity could result in an unhealthy exposure to lead. I agree to hold the Phillipsburg Pistol Club, its officers and trustees, harmless in the event that I am injured or killed. In addition, I further understand that if I leave the club for any reason and do not return my key-fob within one year from the time of resignation or non-renewal, I forfeit any deposit paid.

**JUNIOR MEMBERS BETWEEN THE AGES OF 18 AND 21**

Upon reaching the age of eighteen (18) a junior member may apply for a key fob with 365 day access to all Club facilities and come to the range and shoot by themselves providing, however, they meet and agree to all of the following:

- (1) Have attended a PPC New Member Training class or a club recognized NRA pistol/rifle course.
- (2) Agree to ONLY shoot with a rifle chambered for .22 caliber ammunition.
- (3) Agree to wear a special membership badge authorizing a junior member to shoot alone.
- (4) Must have a valid form of eligibility (see page 1 of the Membership Application).

**ACKNOWLEDGEMENT OF RULES AND REGULATIONS**

I acknowledge that I have received, fully read, understand, accept, and agree to abide by all Club rules including safety rules. A further agree that I will adhere to these rules at all times while on club grounds and/or while representing Phillipsburg Pistol Club, Inc. in any way. #### IV. CERTIFICATION

- (b) I am at least eighteen (18) years of age;
- (c) I am a member of the National Rifle Association (or plan on joining within thirty (30) days);
- (d) I am not currently nor have ever been a member of any organization which advocates or approves the commission of acts of force or violence, either to overthrow the Government of the United States;
- (e) I have not been convicted of, or pleaded guilty to, any crime in any court of competent jurisdiction which would prohibit me from the legal purchase, ownership, possession or control of a firearm or live ammunition under applicable law. If such conviction occurs after my initial membership is approved, I will resign from Phillipsburg Pistol Club, Inc.

I understand that junior members must be at least ten (10) years of age but less than twenty-one (21) years of age and that all junior members who do not satisfy the requirements of the section “Junior members Between the Ages of 18 and 21” (see page 2) must be sponsored by a parent, or legal guardian holding a current membership.

I understand that if I checked no to questions one and two above that my membership will be “provisional” with access to the facilities limited to times when a club appointed safety official is on the premises; days and times are subject to change. Upon successful completion of an approved safety course, and satisfactory attendance at a PPC new member orientation session, I will become a “general member” with access to the facilities at all times that the Club is open to general membership. I understand that if I do not attend a new member orientation session within one (1) year of becoming a member, PPC has the right to refuse my application for renewal.

I further understand that if any of the information provided in any portion of my application to PPC is proven false, I will be subject to immediate forfeiture of membership without refund of any dues and fees paid.
